ANNOUNCEMENT IN RELATION TO PUBLIC FLOAT

The board of directors of Panda Green Energy Group Limited (the “**Company**”) announces that the Company noted Snow Hill Developments Limited (“**Snow Hill**”) increased its shareholding in the Company by 268,420,000 shares, representing approximately 1.2% of the total issued share capital of the Company as at the date of this announcement. As Snow Hill is a party acting in concert with China Merchants New Energy Group Limited* (招商新能源集团有限公司) (“**CMNEG**”) pursuant to an agreement under Section 317 of the Securities and Futures Ordinance, the number of shares held by it shall not be counted into the public float of the Company. As such, the public float of the Company as at the date of this announcement is approximately 24.15%, which has fallen below 25% of the total issued share capital of the Company held by the public as prescribed by Rule 8.08(1)(a) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

To the best knowledge, information and belief of the directors of the Company and pursuant to the information available at present, as at the date of this announcement, the Company’s shareholding structure is as follows:
