PROPOSED ISSUE OF CONVERTIBLE BONDS

On 7 May 2015 (after trading hours), the Company and the Subscriber entered into a non-legally binding Term Sheet, pursuant to which and subject to the entering into of definitive subscription agreement(s), the Company intends to issue and the Subscriber or its affiliate(s) intends to subscribe for the Convertible Bonds in an aggregate principal amount of US\$50 million (equivalent to approximately HK\$387.5 million). The net proceeds from the Proposed Subscription will be used to finance the acquisition of solar power plants in China.

As the parties have not entered into the definitive subscription agreement(s) in relation to the Convertible Bonds, and the final structure and terms of the Convertible Bonds are still subject to further negotiation between the parties, the Proposed Subscription may or may not materialise and its final structure and terms may deviate from those set out in the Term Sheet. Accordingly, Shareholders and potential investors are advised to exercise caution when dealing in the Shares or other securities of the Company. The Company will comply with relevant disclosure and Shareholders' approval requirements under the Listing Rules as and when appropriate.

This announcement is made by the Company pursuant to Rule 13.09 of the Listing Rules and Inside Information Provisions under Part XIVA of the Securities and Future Ordinance (Cap.571, Laws of Hong Kong).

PROPOSED ISSUE OF CONVERTIBLE BONDS

The Board is pleased to announce that on 7 May 2015 (after trading hours), the Company and the Subscriber entered into a non-legally binding Term Sheet, pursuant to which and subject to the entering into of definitive subscription agreement(s), the Company intends to issue and the Subscriber or its affiliate(s) intends to subscribe for the Convertible Bonds in an aggregate principal amount of US\$50 million (equivalent to approximately HK\$387.5 million). The net proceeds from the Proposed Subscription will be used to finance the acquisition of solar power plants in China.

To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, as at the date of this announcement, the Subscriber and its ultimate beneficial owners are third parties independent of the Company and its connected persons (as defined in the Listing Rules).

Based on the information provided by the Subscriber, the Subscriber is an indirect wholly-owned subsidiary of BC Capital Management Group Company Limited ("**BC Capital**"). BC Capital was founded by Mr. Sun Xinrong, the former CEO of Industrial and Commercial Bank of China, Hong Kong branch, along with some of the founding members of Alibaba Group and is principally engaged in investment business and assets management.

PRINCIPAL TERMS OF THE TERM SHEET

The principal terms of the non-binding Term Sheet are set out as follows:

Issuer:	The Company
Subscriber:	BC Global Asset Management Limited or its affiliate(s)
Principal amount:	The aggregate principal amount of US\$50 million (equivalent to approximately HK\$387.5 million)
Interest rate:	7.0% per annum payable annually
Maturity date:	3 years from the Closing Date
Conversion period:	During the period commencing from the date immediately after the end of the sixth month from the Closing Date and ending on the Maturity Date, the Subscriber is entitled to convert all or part of the Convertible Bonds into Conversion Shares.

The Subscriber shall be obliged to convert all outstanding Convertible Bonds into Conversion Shares upon the demand of the Company in the event that:

- (i) the closing price per Share as quoted on the Stock Exchange for any 15 consecutive trading days during the first year from the Closing Date is higher than HK\$1.8; or
- (ii) the closing price per Share as quoted on the Stock Exchange for any 15 consecutive trading days during the second year from the Closing Date is higher than HK\$2.2; or
- (iii) the closing price per Share as quoted on the Stock Exchange for any 15 consecutive trading days during the third year from the Closing Date is higher than HK\$2.5.

Conversion Price: HK\$1.3266 per Conversion Share, which represents 110% of the average closing price of per Share as quoted on the Stock Exchange for the last 5 trading days immediately prior to the date of the Term Sheet.

The initial conversion price per Conversion Share subject to standard adjustments as set out in the definitive subscription agreement(s).

Redemption: On the Maturity Date, the Subscriber shall have the right to request the Company to redeem the principal amount of the outstanding Convertible Bonds at 120% of the principal amount thereof within 15 Business Days from the Maturity Date.

Conditions precedent: The Proposed Subscription shall be conditional upon:

2. the Subscriber having conducted due diligence on the legal position, finance position, assets of the Company and such other due diligence and the results of which having been satisfactory to the Subscriber;
3. the Subscriber having obtained all its approvals, consents and authorizations in respect of the Proposed Subscription;
4. the Company having obtained all its approvals, consents and authorizations in respect of the Proposed Subscription; and
5. the Listing Committee of the Stock Exchange having granted the approval for the listing of and permission to deal in the Conversion Shares.

Save for the provisions regarding the confidentiality, costs and expenses and governing law, the Term Sheet does not constitute a legally-binding commitment on either the Company or the Subscriber on the subject matter. As the terms of the Proposed Subscription are still subject to negotiation and finalization, no definitive subscription agreement in relation to the Proposed Subscription has been entered into as at the date of this announcement. The Company will issue further announcement as required by the Listing Rules when the definitive subscription agreement(s) is/are entered into. It is the parties' intention to enter into the definitive subscription agreement(s) within three months from the date of the Term Sheet.

REASONS FOR THE PROPOSED SUBSCRIPTION

The Company is an investment holding company and the Group is principally engaged in the development, investment, operation and management of the solar power plants. The Company actively explores the investment opportunity to expand its new energy business in order to broadening the income base of the Group, and thereby enhancing the Group's future financial performance and profitability.

The Board considers that the Proposed Subscription, if materialised, represents a good opportunity for the Group to strengthen its financial position including its ability to meet any future obligations, and broaden the Shareholder's base. The net proceeds from the Proposed Subscription are intended to be used to finance the acquisition of solar power plants in China.

The Directors consider that the terms and condition of the Proposed Subscription are fair and reasonable and in the interests of the Company and the Shareholders as a whole.
