Remarks (if any):

1. The Company has entered the Acquisition Agreement on 13 July 2010 and the Supplemental Agreements on 19 2010 July and 22 September 2010 respectively (as disclosed in the Company's circular dated 25 September 2010) pursuant to which the Company will issue (i) an aggregate of 92,936,803 consideration shares at an issue price of HK\$0.538 per consideration share and (ii) convertible note in the principal amount of up to HK\$850,000,000 at a conversion price of HK\$0.538 per conversion share as partial settlement of the consideration for the acquisition.

2. The Company has entered a Placing Agreement on 14 July 2010 (as disclosed in the Company's circular dated 25 September 2010) to place up to 280,000,000 new shares at a price of HK\$0.50 per placing share.

Completion of the above acquisition and placing is subject to shareholders' approval and the fulfillment of the conditions precedent set out in the Acquisition and Placing Agreements.
