As stated in the Company's announcement dated 18 January 2013, the Company has entered into a sale and purchase agreement in relation to the acquisition of approximately 92.17% of the entire issued share capital of China Merchants New Energy Holdings Limited for a total consideration of HK\$2,119,910,000 (subject to adjustment). Subject to the terms and conditions of the sale and purchase agreement, the Company will issue 959,462,250 new shares at an issue price of HK\$1.00 per share and convertible bonds for principal amount of HK\$1,160,447,750 at the initial conversion price of HK\$1.00 per conversion share (subject to adjustment) as total consideration for the acquisition. Upon full exercise of the conversion rights attaching to the convertible bonds, an aggregate of 1,160,447,750 conversion shares will be issued. For details, please refer to the Company's circular dated 10 May 2013.
